Report detailing STCE management of the Twemlows CBF 19th September 2023

Introduction

The Community Benefits flowing from the Twemlows solar farm are a key part of the case for investment in the STCE share offer. This report is to put on public record details of the activities of the Twemlows CBF during the period it has been under the management of Shropshire and Telford Community Energy. The next and future STCE Annual Accounts will include a report on the CBF for that financial year.

Short history

The Twemlows Community Benefit Fund was initially run on by Gower Power as it was an existing community owned organisation with a solar farm, there was no such organisation in Shropshire. Gower Power enlisted the support of the Shropshire Rural Community Council (RCC), a charity based in Shrewsbury, to manage the fund in Shropshire. A steering group was established by Shropshire RCC to manage the distribution of the funds.

In early 2020 STCE came into existence as a "working group" with the intention of bringing Twemlows into community ownership. On 3rd November 2020 a handover meeting was held between STCE and Shropshire RCC. it was agreed, and minuted, at that meeting that:

- 1. STCE would become responsible for the CBF, taking over the role of the steering group.
- 2. STCE would in future ask RCC to manage funds for distribution to community projects within 15 miles of Twemlows. RCC was subsequently renamed Community Resource (CR).
- 3. The rest of the funds would be managed directly by STCE who would target the funds at carbon saving projects throughout Shropshire and T&W.

Flow of Funds

The Twemlows 10MW solar farm was set up as two 5MW solar farms under two operating Community Interest Companies (CICs)—Twemlows 1 CIC and Twemlows 2 CIC. Each company sells the power generated to the grid. After deductions of costs and loan repayments, etc. the resulting Community Benefit Funds arrive at STCE for distribution.

Community Resource report their distribution of their half of the CBF through their own reporting system as part of their year end accounts. CR and STCE each have a documented process by which applicants can apply for grants. These include the criteria used for awarding grants. CR have a standing "Grants" committee for consideration of and decisions on grant applications. They administer a number of grants for different organisations. STCE has been doing this as part of its regular board meetings.
