We are working hard to ensure that we still meet our financial targets for repaying loans, providing community benefits and paying interest to our investors. We still expect to pay 6% interest to our shareholder investors early in 2025, but in the "real world" nothing is guaranteed. Our professional management team in London are doing a good job monitoring the solar farm's performance and managing the planned maintenance and unplanned repairs.

Our Silver Lining?



Update on the Bishop's Castle Heat & Wind project

The wind turbine planning application will be submitted to Shropshire Council very soon. This follows a well-attended, very supportive public meeting in the Three Tuns on 25th September. We'll publicise

the planning reference as soon as we have it, the more people who can write to Shropshire Council in support, the better. Meanwhile the heat network feasibility work is continuing, funded by the grant from the Community Energy Fund. We have strong interest from the SpArC leisure centre, the Community College, a holiday complex and over 40 households. The STCE board have agreed to continue working on the project, an application for Green Heat Network Funding for the final development works and a share of the capital costs should be submitted in January.

The STCE Community Benefit Funds Put to Good Use

Our Community Benefit Funds are having a real impact across Shropshire. Rushbury VH, Festival Drayton Centre and Harmer Hill Village Hall have all fitted rooftop PV, enabled by our CBF grants. For Rushbury we also funded new windows and doors and advised them on new heat pumps. Rushbury has been transformed from "Nice but cold" to "Nice and cosy!!" and STCE was the lead funder for their project!

Little Wenlock VH has now gone completely carbon free, replacing their old gas cooker with a new electric induction cooker. More projects are in the pipeline and there is currently unclaimed money in the local grant pot managed by Community Resource, see https://community-resource.org.uk/service-funding-advice/#grants-for-community-groups.

We have recently increased the maximum on these local grants to £2,000 and whilst priority is given to groups within 15 miles of Prees Heath other Shropshire & Telford groups can also apply.
