Our Second Share Offer is Open

This share offer will enable us to carry out the next phase of securing the Twemlows solar farm, to pay out more from our Community Benefit Fund and increase our membership. We've raised £140,000 in the last 9 weeks but still have a way to go to achieve our main target of £500,000. Thanks to our existing members who've bought more shares and welcome to our 34 new members. If you know anyone else who might be interested, please spread the word. Organisations can also invest.

We maintain our target 6% return on investment and have recently paid out 6% to our existing investor members for 2024. The share offer will close on Nov 14th. See www.stcenergy.org.uk/investors-home.


Bishop's Castle Wind Turbine Approval!

Shropshire & Telford Community Energy and Lightfoot are delighted to announce that Shropshire Council has approved our Wind Turbine planning application at the site near the Connery on Oakley Mynd. Getting to this point has taken 4 years, it is a significant milestone for the heat and wind project. For Bishop's Castle it strengthens the town's commitment to energy transition. It's one of the first turbines to be approved since the government effectively re-opened applications — it's both unusual and impressive that it's a community-based project. We've received many congratulations for this work, including a video message from Hugh Fearnley-Whittingstall.

Meanwhile work continues on the heat side of the project. A report on options for moving that forward will be available soon and there will be a public meeting in Bishop's Castle on the evening of Sept 10th. See https://lightfootenterprises.org/heat-network/ for more details of the scheme.

Record Output from Twemlows

After a slightly disappointing year in 2024 we have generated 20% more electricity than forecast in the first six months of 2025, over 6,000,000 kWh!

On a recent site visit we counted six skylarks on the site and apparently 40% of our bird boxes were used this year. We will be organising more volunteer work parties on site late September/early October.

STCE 2025 AGM

19 people attended our 2025 AGM and 22 sent apologies. The annual report and accounts were accepted; Neil Pulker was voted on as a new director and Rob Saunders and Dave Green were reelected. Thanks to all who attended or sent in proxy votes, particularly Becky Oliver who ran the voting tech for us. Rob Saunders is continuing as Chair, Dave Green as Treasurer and also Howard Betts as Secretary, although we are looking for a replacement secretary so Howard can cut down on his STCE workload.
